

# Reducing Smoking in Queensland -

This survey provides an opportunity for all community members, industry and organisations to provide feedback on the options provided in the Consultation Paper - *Reducing the negative effects of smoking in Queensland*.

The options canvassed in the consultation paper include proposed changes to the *Tobacco and Other Smoking Products Act 1998* (the Act) to increase smoke-free public areas and strengthen controls on smoking product advertising and supply.

The survey is arranged by the seven topics considered in Section 2 of the consultation paper. You can provide responses to all topics or select the topics you wish to provide a response for.

Please note: There is a 45 minute time limit for completing the survey from the time you start filling it out. To save your response, click the **Finish later button** (within the 45 minute time limit) —you will be given an address and a password, which you can use later to complete your survey.

Responses to individual topics are expected to take up to 15 minutes depending on the amount of information you wish to provide. Responding to the full survey could take more than an hour and respondents are encouraged to use the Finish later button to ensure responses are captured.

## Topic 1 - Monitoring compliance of retail smoking product supply

1.1 - *The recommended option is to amend the Act to require suppliers of smoking products to obtain a licence (option 3)? Please advise if you agree or disagree with this option and why? AMA Queensland supports these measures to more appropriately and rigorously regulate, and monitor compliance with, the retail and supply of smoking products. Any potential impediments or complexities to tobacco suppliers and retailers flowing from these changes are outweighed by the significant personal and public health benefits of smoking reduction.*

It is vital that vending machines are completely inaccessible to young people and that all avenues for sale are stringently regulated and monitored, with enforcement action taken for any breaches.

## **Topic 5 - Smoking at liquor licensed venues**

5.1 - The recommended option is to amend the Act to introduce a hybrid combination of requiring smoke-free buffers between DOSAs and enclosed areas, and restricting DOSA access to adults and prohibiting drinking in a DOSA? (option 6) Please advise if you agree or disagree with this option and why? AMA Queensland supports these measures, noting the potential for these measures to help reduce social activity involving smoking. This is welcome in terms of reducing the frequency and duration of smokers' visits to designated outside smoking areas, and reducing the likelihood of non-smokers accompanying smokers into a designated outside smoking area. Prevention of access to designated outdoor smoking areas by children is essential, both for reducing children's exposure to behaviours that normalise smoking, and reducing children's exposure to second-hand smoke.

6.1 - The recommended option is to amend the Act to introduce a combination of smoke-free buffers around the perimeter of all outdoor eating or drinking places, and introduce restrictions on areas used as smoking-only areas at outdoor eating or drinking areas (option 5)? Please advise if you agree or disagree with this option and why? Consistent with the response to Topic 5, AMA Queensland supports these measures, noting their potential to help reduce the appeal of spending

time in an outdoor designated smoking area. Physical space designated to facilitating smoking should be minimal, and other patrons should be completely protected from drifting second-hand smoke.

Given the often family-friendly nature of outdoor markets, it is essential that other people, especially children, are protected from second-hand smoke. It is also essential to minimise opportunities for children to witness smoking behaviours in a way that normalises them, and to reduce incidental triggers for people wishing to reduce or quit their own smoking.
