Re: Automated External Defibrillators (Public Access) Bill 2022

Thank you for the opportunity to comment on the Bill introduced by the Hon Frank Pangallo MLC that seeks to mandate the installation and registration of Automated External Defibrillators (AEDs) in designated buildings, facilities and vehicles.

In developing this response, I have sought the opinions of those members of the AMA in South Australia whose roles lead them to care for patients with cardiac issues on a daily basis, including cardiologists and emergency physicians.

AMA(SA) believes there is strong evidence of the value of having AEDs in as many public and private facilities and spaces as possible, to help save many of the Australians who die from cardiac arrests. The Australian Genetic Heart Disease Registry website indicates that sudden cardiac arrest claims the lives of more than 22,000 Australians each year, and that 'immediate CPR and defibrillation in the first few minutes' may save a person's life. The introduction and ready availability of any tool that could prevent even a few of these deaths should be considered by a government wishing to ensure its citizens have access to world-class health care. Now, with the Therapeutic Goods Administration approving the sale of the 'hand-held' CellAED – a device the manufacturer's website indicates costs \$360 for a single use or \$359 plus a monthly fee of \$16.50 'for life' – there are lower-cost options than those costing around \$2,000.

However, we understand that many businesses would not feel they were in a position to pay for the installation and maintenance of AEDs, and for the training that – depending on the type – may be required upon installation and on an ongoing basis. We understand that there is little training needed; however, business personnel may require some education and practical knowledge to feel confident in using the equipment in emergency situations.

It has been suggested that the gathering and promotion of more information about the benefits of the devices and the lives they have saved may make business owners more willing to pay for the devices. Independent, non-commercial information that outlines the cost per heart attack, for example, could support such promotion.

However, it has been pointed out that it is not yet mandated that all vehicles that carry patients to and from hospitals and health facilities in South Australia are fitted with permanent defibrillators. If this is the case, we recommend that the fitting of AEDs in all
