Nominations, which must be in writing and comply with the registered rules of the Federation, may be made at any time from 8 August 2018.

Prospective candidates should verify their financial status and any other qualifications required by the Federation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 5:00pm Australian Eastern Standard Time (AEST) **on** 29 August 2018.

* Branch Councillors are elected by, and from, Financial Members employed (if any) in each of the Practitioner Types.

* Where a Branch has no members employed in a Practitioner Type at the opening of nominations for the election of the Branch Councillors, then the office of that respective Practitioner Type will remain vacant for the three (3) year term that follows.

2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Nominations cannot be withdrawn after 5:00pm Australian Eastern Standard Time (AEST) on 29 August 2018.

Voting Period

The ballot, if required, will open on 19 September 2018 and close at 10:00am Australian Eastern Standard Time (AEST) on 10 October 2018.


Scrutineers
