## GETTING RESULTS FOR GENERAL PRACTICE

- The AMA won Government funding for many general practices that employ a practice nurse. We're pushing for the assistance to be available to all general practices.
- We're cutting the red tape the AMA has had the red tape-intensive enhanced primary care items replaced with simpler chronic disease management items.
- The AMA initiated supervised prevocational terms for junior doctors in general practice – giving new doctors valuable experience at a crucial time in their training.
- Doctors recently found they were being denied payment after having bulk-billed a concession card patient in good faith. The AMA met with Government and quickly put a stop to this problem.
- AMA lobbying resulted in 16 new afterhours Medicare items for GPs working after 8pm. Patient rebates for these items are \$10 greater than for in-hours consults. We're working to make Government properly value after hours care.
- Due to the AMA's hard work, preventive care provided by GPs is being valued for the first time with a new item that will allow GPs to detect and prevent chronic disease for people around 45 years of age with one or more health risks.
- The AMA convinced the Government to introduce a Medicare item for GPs to provide comprehensive health assessments for refugees.



- The AMA won a 17 per cent increase in Medicare patient rebates for antenatal checks by GPs.
- We convinced Government to increase the Medicare patient rebate for most services provided by a GP, from 85 per cent to 100 per cent of the Medicare schedule fee.
- Thanks to AMA negotiations, new MBS items have been created to allow GPs to provide more time and specialised care to patients with a chronic disease.
- When GPs are unfairly penalised or pursued by government agencies the AMA has successfully intervened to protect doctors' interests.
- The AMA brokered an agreement that ensures GP registrars receive a fair minumum wage and reasonable working conditions.

# ONGOING ADVOCACY FOR GENERAL PRACTICE

- The AMA is pushing for a single Medicare provider number for GPs the current system creates a significant administrative burden for doctors.
- We're working to have the prescription authorities system removed or, at worst, streamlined.
- The AMA is fighting for an improved electronic claiming system to cut back on red tape for GPs and reduce patients' up front costs.
- We're lobbying to reform the MBS so that GP-led teams can more easily work to provide quality, sustainable patient care.
- The AMA is promoting a restructure of the MBS that rewards quality practice.
- Reform of aged care also is in our sights – we're looking to change the aged care items to recognise the true value of this service and enable GP nurses to participate in patient care.
- The AMA is pursuing appropriate indexation of the MBS to keep pace with the

increasing cost of providing services.

- We are protecting the interests of doctors and patients in the development and implementation of e-health initiatives.
- The AMA negotiates to ensure new MBS items reflect the realities of general practice and the real value of services.

#### Leadership opportunities
