Workers Compensation Reform Committee

Update for AMA Members

An AMA Delegation met with the (then) new WorkCover Minister, Mr Adam Brooks in early April 2016 to explain the origins of the AMA committee and provide a brief timeline of the committee's activities i.e. promotion of better understanding of the potential for negative health effects from compensation processes, recommend system and legislative improvements to the WorkCover Minister and Board and ongoing dialogue with insurance companies about issues of concern.

AMA initiatives/recommendations include:

- 1. Introduction of scheme health outcome measures
- 2. Proposals for alternative clinical pathways for GP-identified poor-prognosis cases i.e. "Complex Case Management"
- 3. Measures to enhance medical input into system design and oversight, independent medical examiner standards, impairment assessment procedures and medical dispute resolution
- 4. Ongoing direct dialogue with insurers through the AMA Insurer Forum
- 5. Review of impairment assessment procedures following spinal surgery
- 6. Promoting the use of Medical Panels in dispute resolution

GP Update

Revised Application to Prescribe S8s

The AMA continues to work with the Pharmaceutical Services Branch on redesigning the application to prescribe S8s beyond two months. It is recognised by all that the management of chronic non-cancer pain is particularly challenging in Tasmania due to the limited referral services and the failure of any government service to put up its hand and take ownership of this neglected area of public health. Despite the lack of resources, the Pharmaceutical Services Branch is determined to reduce the prescribing of S8s for chronic non-cancer pain in Tasmania, and the AMA will continue to work with the Pharmaceutical Services Branch in developing a workable and best practice application process. It is strongly recommended that members read a recent report by coroner Stephen Carey that summarises the problems in this area particularly well and makes very thoughtful suggestions to address the issue of S8 prescribing in Tasmania.

Revised Transport Access Scheme Application Form

The AMA was disappointed to see the new Transport Access Scheme application form rolled out without consultation. The expectation that drivers medical can be done as part of filling this form out for those applicants who want to continue to hold their driver's licence is obviously not practical in General Practice. State Growth will be advised of this and in the interim the AMA advises members to ask applicants to rebook for the usual full medical if they also want to continue to hold a drivers licence.

Early Access to Defibrillation

The Tasmanian Ambulance Service continues to build its database of the location of defibrillators in Tasmania and medical practices with defibrillators that have not notified Tasmanian Ambulance Service of their defibrillator are encouraged to participate in this excellent initiative. Workers Compensation developments The AMA continues to work with the State Government and Insurance companies to try and redesign the worker's compensation process in Tasmania. An update for members is included in this newsletter.

Palliative Care Tasmania Representation to the Legislative Council

Provocative statements made by the CEO of Palliative Care Tasmania at a Legislative Council inquiry into Palliative Care in Tasmania will be followed up by the AMA at a formal level with the governing Council of Palliative Care Tasmania. It is anticipated the majority of the statements reported in the press (see attached) will be

withdrawn, and the AMA will be arguing for a formal apology to correct the public record.

FULL STORY

Working with Vulnerable People Registration - initially, affects those working with children (person <18yo)

The AMA has written confirmation from the Justice Department that doctors working in private practice do not require this registration. If however, a doctor works for another organisation although registration is optional the organisation can enforce the doctor to obtain this registration as part of their employment or contract requirements.
